QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

1. SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.
2. STANDARD. The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.
3. PROCEDURES.
 - (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
 - (b) The COR will complete appropriate documentation to record the complaint.
 - (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

(d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

(e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

(f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

(g) The COR will consider complaints as resolved unless notified otherwise by the complainant.

(h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.]

I. Background

Overland transportation of cargo and helicopters in support of DOS Technical directive # 112 "Receipt of Aircraft and Preparation" for Load and Ground Transportation of (3) UH-1HII Aircraft from Pucallpa to Lima and (3) UH-1HII aircraft from Lima to Pucallpa.

II. Scope

Arrange for the safe and timely shipment of six (6) helicopters, ground support equipment and aircraft parts and components cargo from **Pucallpa - Lima - Pucallpa**

III. Basis of Award

INL anticipates issuing a Purchase Order to the Vendor whose Quote provides the best value to INL, price, and other factors considered.

III. Objectives

Safe and timely shipment of assets identified on this SOW

IV. Project/Task Objectives and Requirements

Service before November 9, 2020:

Transportation of THREE (03) helicopters and cargo from MOB Pucallpa to Lima, Peru:

Contract of **three (03) Over-The-Road-Truck, "Low-Boy"** with four axels. The size of each truck must be sufficient to allocate and transport one helicopter UH-1H-II with a weight of 6,580 pounds and the following dimensions, length 13.20 mts, width 3.00 mts, height 3.40 mts.

The helicopters will be load in Pucallpa by INL Aviation Contractor AAR personnel and secured on the trucks by the Transportation Company. No crane needed in Pucallpa.

The loading process will not take more than 4 hours; remember that transporter must provide means to cover the cargo. Once in Lima the download of the aircraft will take no more than 4 hours, a 3 ton crane will be needed for this too.

Contract the service to provide and operate **1 (one) Crane, on or before November 9, 2020** in **Lima** with sufficient capacity to safely lift and **unload** three Helicopters UH-1H II from "Low-Boy" trucks coming from Pucallpa.

Service before November 9, 2020

Transportation of THREE helicopters and cargo from Lima to MOB Pucallpa, Peru:

Contract of three (3) **Over-The-Road-Truck, "Low-Boy"** with four axels. The size of each truck must be sufficient to allocate and transport one helicopter UH-1H-II with a weight of 6,580 pounds and the following dimensions, length 13.20 mts, width 3.00 mts, height 3.40 mts

Contract the service to provide and operate **1 (one) Crane, on or before November 9, 2020**, in **Lima** with sufficient capacity to safely lift and load three Helicopters UH-1H II to “Low-Boy” trucks going to Pucallpa.

The helicopters will be unloaded in **Pucallpa** by INL Aviation contractor AAR personnel. No crane service needed.

NOTES:

Additionally, each low boy must have the following accessories: 1) A tarp to cover the helicopter entirely and to prevent from external damages to the aircraft during its transportation. 2) Cargo straps and/or chains to secure cargo; 3) Tie down points in the “Low-Boy” to secure the aircraft safely.

After arriving to Lima, which has to be 4 days before C17s’ flight arrival, loading of the aircraft to go back Pucallpa will happen after 48 hours of the C17s’ flight departure. Trucks may not wait in Group 8 premises to upload aircraft on the way back to Pucallpa.

It is of maximum importance to take into consideration that the total height of the “Low-Boy” platform plus the Helicopter may access freely through the Carpish tunnel located in Aguaytia, Peru.

Additional requirements:

Vehicles shall comply with the Peruvian Transportation laws and regulations (*SOAT*).

Vendor vehicles shall be insurance holders against damage, lost, theft to cargo / property during performance of work.

The service must include professional drivers with valid driving licenses and experienced with the operation of this type of truck and the handling of cargo.

Transportation Company selected must include and enumerate the level of insurance coverage included as part of their service, but not less than \$100,000. As well as legal documentation and permits to the transportation complying with all the requirements of the local authorities at each region in the country. Approximate cost of each aircraft is \$ 992,740.

Additionally, requests information regarding the transit times for the ground transportation, itinerary, estimated dates and times of pickup, departure and delivery of cargo; copy the current license of transit of the truck and current licenses of the drivers.

(c)(1) If the Contractor is a foreign person and has only a partial or no exemption to the withholding, the Contractor shall include the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, with each voucher or invoice submitted under this contract throughout the period in

which this status is applicable. The excise tax withholding is applied at the payment level, not at the contract level. Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Specified Federal procurement payment means any payment made pursuant to a contract with a foreign contracting party that is for goods, manufactured or produced, or services provided in a foreign country that is not a party to an international procurement agreement with the United States. For purposes of the prior sentence, a foreign country does not include an outlying area.

United States person as defined in 26 U.S.C. 7701(a)(30) means—

(1) A citizen or resident of the United States;

(2) A domestic partnership;

(3) A domestic corporation;

(4) Any estate (other than a foreign estate, within the meaning of 26 U.S.C. 701(a)(31)); and

(5) Any trust if—

(i) A court within the United States is able to exercise primary supervision over the administration of the trust; and

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). The Offeror would claim an exemption from the withholding by using the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, available via the internet at www.irs.gov/w14. Any exemption claimed and self-certified on the IRS Form W-14 is subject to audit by the IRS.
